Summary

- 1. Brentwood and SJC MOU regarding Prop 1 Grant--still in process (currently with SJC)
- 2. GSA information on SGMA portal to be updated with subbasin name change (from Tracy to ECC Subbasin) include:
 - a. GSAs MOU-Ryan will draft a one paragraph description of subbasin name change to include as an addendum to the MOU. This will be ready for all GSAs to review by mid-August.
 - b. GSA resolution-each GSA will review their own resolution (to become a GSA) and decide how/if to update with the name change.
 - c. GSA boundary changes-DWD/CCC have one boundary change. Ryan/CCC will update maps and GIS files with this change and provide a new ECC Subbasin map and the individual GSA boundary maps.
 - d. Interested parties list-Ryan and Debbie will review and update as needed
 - e. Each GSA will find their login information for SGMA GSA Portal site
 - f. Going forward-GSA boundary changes for the ECC Subbasin will be reviewed and updated once/year in summer

3. Outreach

- a. CCC and DWD will place newspaper ads with information on the ECC GSP instead of sending out 3,000+ postcards.
- b. Ryan/Debbie will revise newspaper ad language and send to group for review.
- c. City of Antioch will send postcards to 30 well owners in the City once the language is finalized for newspaper ad.
- d. Instead of a workshop, each GSA will provide reports to their Board and these are open to the public.
- e. Utility bill message--Twice a year (April and October, starting Oct 2019), utility bills from TODB, DWD, Cities of Brentwood and Antioch will include a message about how to receive information about the GSP and provide a link to the website.
- f. GSAs will email LSCE a list of meetings where the ECC GSP was discussed.
- g. CCWD/Maggie/Jill-Add 8 logos to header of ECC GSP webpage
- h. ECCID-will have website live by fall 2019

4. Prop 68 Grant

a. LSCE will provide an outline of the application to the GSAs for review. The application will include a GSP development component and possibly a component for installation of dedicated groundwater monitoring wells (to be discussed).

b. It was decided that planning and design projects will not be included in this application but will be part of the Prop 68 implementation grant (summer 2020).

5. GSP Updates

- a. Data Gap Map--Ryan/CCC will update the public lands map and include the proposed SW/GW locations as well as creating a zoomed in map for each location.
- b. City of Antioch has not been successful in finding well owners willing to participate in the CASGEM monitoring program.
